**RECEIVER'S UNOPPOSED MOTION TO CONDUCT
CASE MANAGEMENT MEETING USING ZOOM**

Burton W. Wiand, as receiver for the plaintiff entities (the “**Receiver**”), moves the Court to allow the parties to conduct a case management meeting using the Zoom video-conferencing platform. If permitted, the parties have scheduled a Zoom meeting for September 22, 2020 at 2:00 PM. The template case management report accompanying the Court’s order (*see* Doc. 7 at 9), however, provides that “[l]ead counsel must meet *in person* and not by telephone absent an order permitting otherwise.” Given the COVID-19 pandemic, counsel for both parties would prefer to meet using Zoom. During a hearing on July 16, 2020, the Court raised the possibility of using Zoom to address subsequent matters, and previously, on March 23, 2020, the Court entered an order suspending all “in person requirements.” The order also provided as follows: “Travel for purposes of litigation is strongly discouraged at this time. The use of video and other means of conducting discovery

is encouraged.” The defendant’s attorneys are based in Orlando, and the Receiver’s attorneys are based in Tampa. The order, however, appears to have expired on or about May 23, 2020. As a result and in an abundance of caution, the Receiver files this motion seeking express leave of Court to use Zoom, given the language in the template case management report on page 9 of Doc. 7.
