### RECEIVER'S CONSOLIDATED NOTICE OF PUBLICATION REGARDING THE SALE OF 4058 FOUNDERS CLUB DRIVE IN SARASOTA, FLORIDA

On January 29, 2021, Burton W. Wiand, as receiver (the "**Receiver**") over the assets of the above-captioned defendants and relief defendants (the "**Receivership**" or "**Receivership Estate**"), filed his Unopposed, Verified Motion to Approve the Private Sale of Real Property – Specifically, 4058 Founders Club Drive in Sarasota, Florida (the "**Motion**"). Doc. 363. A notice of the proposed sale was attached as Exhibit 5 to the Motion. On February 2, 2021, the Receiver published the notice in the *Sarasota Herald-Tribune*, which is regularly issued and of general circulation in the district where the property is located. An affidavit of publication is attached as **Exhibit A**. More than 10 days have elapsed since the Receiver published the notice, and no individual or entity has submitted a "bona fide offer" pursuant to 28 U.S.C. § 2001(b).

Because the Motion was unopposed, the Court entered an order granting the requested relief on February 2, 2021. Doc. 365. As such, <u>no</u> <u>further judicial action is requested or required</u>. The Receiver files this notice, however, in an abundance of caution to inform the Court, the parties, and others that the Receiver complied with the requirements if 28 U.S.C. § 2001(b), but no "bona fide offer" was submitted. The transaction is scheduled to close on or about February 19, 2021, and if it closes as anticipated, the proceeds will be reflected in the Receiver's next interim report.
