ORDER

This cause comes before the Court for consideration of Plaintiff's Motion for Limited Relief from the Stay to Conduct Discovery as to Non-Party ATC Brokers, Ltd. and Related

Non-Party Entities and Individuals (Doc. 391). None of the parties oppose the granting of the relief sought.¹

Having considered the motion, and being otherwise fully advised, it is **ORDERED AND ADJUDGED** that Plaintiff's Motion for Limited Relief from the Stay to Conduct Discovery as to Non-Party ATC Brokers, Ltd. and Related Non-Party Entities and Individuals (Doc. 391) is **GRANTED**. Plaintiff is granted limited relief from the stay of this litigation² such that Plaintiff may issue Federal Rule of Civil Procedure 45 subpoenas to ATC Brokers, Ltd., as well as to any other non-party entities and individuals Plaintiff believes likely to possess relevant information related to claims and possible defenses involving the ATC Brokers, Ltd. and its related entities.
