**ORDER**

This cause comes before the Court for consideration of the Receiver's Fifteenth Interim Motion for Order Awarding Fees, Costs and Reimbursement of Costs to Receiver and His Professionals (Doc. 724). Plaintiff Commodity Futures Trading Commission ("CFTC") does not oppose the granting of the relief sought and neither do Defendants Anile, Da Corta,

Montie, and Duran (Doc. 724 at 24). The Receiver did not consult the United States (as an intervening party) because the government has not previously taken a position on the Receiver's fee applications, and the stay the government obtained expired on July 24, 2022, after Defendant DaCorta's criminal trial. Although the Receiver notes that Defendant Haas objects to the motion, Haas has not responded and the deadline to do so has passed. *See* L.R. 3.01(c), M.D. Fla. (2021). As no responses were filed, the motion is deemed unopposed. *Id.*

Upon due consideration, the Receiver's Fifteenth Interim Motion for Order Awarding Fees, Costs and Reimbursement of Costs to Receiver and His Professionals (Doc. 724) is **GRANTED**. The Court awards the following sums and directs that payment be made from the Receivership assets:
