ENDORSED ORDER finding as moot in part, denying in part, and taking under advisement in part [74] Motion in Limine as to Michael J. Dacorta (1). The Court will consider at a timeframe closer to trial whether any protectible attorney-client communications exist between Attorney Anile and the person of Michael DaCorta that might present an issue at trial. The Court finds that the receivership orders and the consent to same by Mr. DaCorta address whether the receiver possesses the attorney-client privilege for the receivership entities. The Court finds that the receiver does so possess this privilege for those entities as set forth in the receivership orders. The Court determines, based on the Government's representation, that the Government's case in chief is not anticipated to cover the early (circa 2002, pre-Oasis) attorney client communications between Anile and DaCorta. There is presently little to no likelihood that DaCorta's attorney-client communications with Anile from that pre-Oasis era might come into evidence. Signed by Judge William F. Jung on 11/29/2021.
