FINAL JUDGMENT IN GARNISHMENT AGAINST PIOTR LUDA'S SALARY AND WAGES WITH AMBIT ENERGY HOLDINGS, LLC

THIS CAUSE came before the Court without a hearing on Plaintiff's, BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; AND SATELLITE HOLDINGS COMPANY ("Receiver"), Motion for Default Final Judgment in Garnishment Against Piotr Luda's Salary and Wages with Ambit Energy Holdings, LLC ("Motion") and this Court having reviewed

the Motion, the docket, and being otherwise duly advised in the premises, hereby finds as follows:

- 1. On November 3, 2020, the Honorable Virginia M. Hernandez Covington entered an Order directing the Clerk to enter a Final Judgment in favor of the Receiver and against Defendant/Judgment Debtor PIOTR LUDA ("*Defendant*"), individually, in the amount of \$8,035.49 (Doc. 592). Accordingly, on November 4, 2020, the Clerk entered a default judgment against Defendant in the amount of \$8,035.49 (Doc. 623). Subsequently, on April 19, 2021, the Clerk entered an Amended Default Judgment in the amount of \$8,826.19 ("*Judgment*"). (Doc. 760).
- 2. The sum of \$8,826.19, plus post judgment interest, remains due and unpaid on the Judgment.
- 3. On April 22, 2022, the Receiver filed an *Ex Parte* Motion for Continuing Writ of Garnishment related to Garnishee. (<u>Doc. 1173</u>).
- 4. On June 6, 2022, the U.S. Marshal served Garnishee with the Post-Judgment Continuing Writ of Garnishment ("Writ") (Doc. 1198). See Doc. 1206.
- 5. Garnishee failed to file its Answer of Garnishee on or before June 26, 2022, thereby entitling Plaintiff to default and final judgment in garnishment pursuant to Fla. Stat. § 77.081.

- 6. The Plaintiff served proper notice on Defendant regarding the Writ. (Doc. 1208).
- 7. Defendant has not objected to the Writ, filed a claim of exemption, or moved to dissolve the Writ.

It is therefore **ORDERED AND ADJUDGED**:

- 8. Final Judgment in Garnishment is hereby entered in favor of Plaintiff BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; AND SATELLITE HOLDINGS COMPANY, whose address is c/o Beatriz McConnell, Esq., Englander Fischer, 721 First Avenue North, St. Petersburg, FL 33701, and against Garnishee, AMBIT ENERGY HOLDINGS, LLC, the address of which is c/o Registered Agent, 206 E 9th Street, Suite 1300, Austin, TX 78701.
- 9. Pursuant to the Final Judgment and Writ, Plaintiff does have, receive and recover from the Garnishee, AMBIT ENERGY HOLDINGS, LLC the sum of \$8,826.19 for all of which amount let execution issue forthwith.
- 10. The Court retains jurisdiction to enter orders as may be necessary to enforce this Final Judgment.

11. The Plaintiff is entitled to attorney's fees pursuant to <u>Fla. Stat. § 57.115</u>. The Court retains jurisdiction to determine a reasonable fee award.
