**RECEIVER’S NOTICE REGARDING BANKRUPTCY STAY (DOC. 1216)**

Plaintiff, BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; and SATELLITE HOLDINGS COMPANY (“*Receiver*”), pursuant to the Court’s July 25, 2023 Order (Doc. 1216), notifies the Court that the Defendant, ROCCO GARBELLANO (“*Garbellano*”) and Receiver are in agreement that the stay may be lifted as to Garbellano.<sup>1</sup> On August 1, 2023, counsel for Garbellano advised Receiver’s counsel that Garbellano agrees

<sup>1</sup> On May 9, 2022, Garbellano filed a Suggestion of Bankruptcy (Doc. 1182) and this Court entered an Order staying and administratively closing this case as to Garbellano on June 2, 2022 (Doc. 1203). The Receiver notified the Court that Garbellano’s bankruptcy case was dismissed (Doc. 1215) and the Court directed the Receiver and Garbellano to advise the Court regarding whether the stay may be lifted (Doc. 1216).

that there is no basis to keep the stay in place and requested that undersigned counsel represent the same to this Court by way of this notice. Accordingly, the parties are in agreement that the stay may be lifted as to Garbellano.
