**PLAINTIFF'S MOTION FOR DEFAULT JUDGMENT AGAINST DEFENDANT
GREGORY CORCORAN**

Plaintiff, BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; AND SATELLITE HOLDINGS COMPANY (“*Plaintiff*”), pursuant to Fed. R. Civ. P. 55(b)(1) and Local Rule 1.07(b), moves the Clerk of Court to enter a default judgment in the amount of \$19,311.51 plus prejudgment interest beginning from the date of each false profit distribution through July 31, 2020 in the amount of \$3,128.15 and continuing thereafter at a per diem rate as a decimal of 0.0001647540 against Defendant, GREGORY CORCORAN (“*Corcoran*”), and states as follows:

1. On April 15, 2019, Plaintiff was appointed by the Court presiding over *C.F.T.C. v. Oasis International Group, Ltd.*, Case No. 8:19-CV-886-T-33SPF (M.D. Fla.) (the “*Receivership Case*”), as the Receiver and directed Plaintiff to take custody, control and possession of the Receivership Estate. See Wiand Affidavit attached hereto as **Exhibit “A.”**

2. In connection with Plaintiff's appointment in the Receivership Case, Plaintiff initiated this action and on April 14, 2020, Plaintiff filed his Complaint against Corcoran (Doc. 1).

3. On May 4, 2020, Plaintiff notified Corcoran of this action and requested a waiver of the service of summons pursuant to Fed.R.Civ.P. Rule 4(d). (Exhibit A ¶ 4).

4. Corcoran timely served Plaintiff with the executed waiver, which required him to file a responsive pleading on or before July 6, 2020. (Doc. 11). (Exhibit A ¶ 5).

5. Corcoran failed to serve or file a responsive pleading or otherwise defend this action. On July 16, 2020, Plaintiff moved for entry of a clerk's default. (Doc. 220). On July 17, 2020, the Clerk entered a default against Corcoran. (Doc. 228). (Exhibit A ¶ 6).

6. Upon information and belief, Corcoran is not an infant or an incompetent person or an active duty member of the U.S. Military. (Exhibit A ¶ 7).

7. As set forth in the Complaint, Plaintiff seeks recovery of a sum certain in the amount of \$19,311.51 against Corcoran plus prejudgment interest beginning from the date of each false profit distribution through July 31, 2020 in the amount of \$3,128.15 and continuing thereafter at a per diem rate as a decimal of 0.0001647540. *See* Compl. Ex. A at 16 (Doc. 1); (Exhibit A ¶ 8).

Legal Memorandum

Fed.R.Civ.P. 55(a) provides that, "[w]hen a party against whom a judgment for affirmative relief is sought has failed to plead or otherwise defend, and that failure is shown by affidavit or otherwise, the clerk must enter the party's default." Additionally, Rule 55(b)(1) provides that if the plaintiff's claim is for an amount certain or can be made by certain computation (on plaintiff's request and with an affidavit showing the amount due), the clerk must enter judgment for that amount against a defaulted defendant. In this case, because Corcoran failed to respond to the Complaint, Corcoran is neither a minor nor an incompetent person, and

Plaintiff has set forth the sum certain of \$19,311.51 plus prejudgment interest beginning from the date of each false profit distribution through July 31, 2020 in the amount of \$3,128.15 and continuing thereafter at a per diem rate as a decimal of 0.0001647540 with an affidavit showing same, the Clerk must enter a default judgment in the amount of \$19,311.51 plus prejudgment interest, beginning from the date of each false profit distribution through July 31, 2020 in the amount of \$3,128.15 and continuing thereafter at a per diem rate as a decimal of 0.0001647540.

WHEREFORE, Plaintiff moves for entry of a Default Judgment in the amount of \$19,311.51 plus prejudgment interest beginning from the date of each false profit distribution through July 31, 2020 in the amount of \$3,128.15 and continuing thereafter at a per diem rate as a decimal of 0.0001647540 against Corcoran.
