**PLAINTIFF’S MOTION FOR ENTRY OF CLERK’S DEFAULT AGAINST  
DEFENDANT MARY CHARUK**

Plaintiff, BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; AND SATELLITE HOLDINGS COMPANY (“*Plaintiff*”), through undersigned counsel and pursuant to Fed. R.
