**PLAINTIFF'S MOTION FOR ENTRY OF CLERK'S DEFAULT AGAINST
DEFENDANT BLACK DRAGON CAPITAL, LLC**

1. On April 14, 2020, Plaintiff filed his Complaint against Black Dragon Capital (Doc. 1).
2. On June 30, 2020, Plaintiff served Black Dragon Capital with the summons and complaint. See Affidavit of Service filed on July 22, 2020 (Doc. 252), attached hereto as **Exhibit "A."**
3. By Endorsed Order entered on August 14, 2020, the Court granted Black Dragon Capital thirty (30) days to respond to the Complaint or pursue other remedies (Doc. 333).


