**PLAINTIFF'S MOTION FOR ENTRY OF CLERK'S DEFAULT AGAINST
DEFENDANT PIOTR LUDA**

Plaintiff, BURTON W. 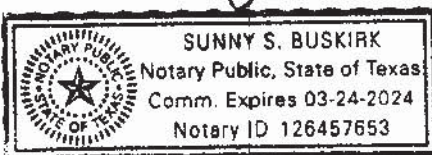
