**PLAINTIFF'S MOTION FOR ENTRY OF CLERK'S DEFAULT AGAINST  
DEFENDANT VINCE PETRALIS, SR.**

Plaintiff, BURTON W. WIAND, as Receiver for OASIS INTERNATIONAL GROUP, LTD.; OASIS MANAGEMENT, LLC; AND SATELLITE HOLDINGS COMPANY ("***Plaintiff***"), through undersigned counsel and pursuant to Fed. R. Civ. P. 55(a), moves the Clerk of Court to enter a default against Defendant, VINCE PETRALIS, SR. ("***Petralis, Sr.***"), for failure to plead or otherwise defend, and states:

1. On April 14, 2020, Plaintiff filed his Complaint against Petralis, Sr. (Doc. 1).
2. On July 1, 2020, Plaintiff served Petralis, Sr. with the summons and complaint. See Affidavit of Service filed on July 22, 2020 (Doc. 255), attached hereto as **Exhibit "A."**
3. Petralis, Sr. filed a Motion for Joinder to David Lipinczyk's Motion to Quash Summons and Object to Jurisdiction on July 23, 2020 (Doc. 261) which was denied by Oral Order on August 17, 2020 that directed Petralis, Sr. to file an answer to the Complaint by September 16, 2020 or be subject to entry of default (Doc. 344).
