ENDORSED ORDER directing the Clerk to set aside Clerk's entry of default against Defendant David Wilkerson. (Doc. # [557]). On November 2, 2020, the Clerk docketed a letter from Mr. Wilkerson dated October 27, 2020. (Doc. # [556]). Mr. Wilkerson explained he would be representing himself pro se, contested the amounts listed in the complaint, and stated he hoped the parties could resolve the situation before the March 20, 2021, mediation. Furthermore, Mr. Wilkerson informed the Clerk to whom he addressed the letter that he had requested his records concerning investments to the Fund. (Id.). Mr. Wilkerson's letter is not a responsive pleading to the complaint. The Court instead construes it as a motion for extension of time to file a responsive pleading. If Mr. Wilkerson wishes to contest the allegations of the complaint, he needs to file an appropriate responsive pleading by December 7, 2020. If he fails to do so, Mr. Wilkerson will be subject to entry of default and default judgment. Furthermore, Mr. Wilkerson is directed not to correspond with this Court or employees of the Clerk's Office with respect to matters at issue. The proper procedure is to file a pleading.
