ENDORSED ORDER denying Defendants James Jackson and Timothy Hunte DBA KATT Distribution's motions for extension of time to complete discovery. (Doc. ## [683], [684]). The Court has an independent obligation to move its cases forward and resolve cases as quickly as possible. Under the current case management and scheduling order, the discovery deadline is April 14, 2021. (Doc. # [517]). The Court believes this is sufficient time to conduct discovery. Thus, the requests are denied. Furthermore, the Court notes that both motions fail to comply with Local Rule 3.01(g). Pursuant to Local Rule 3.01(g), the moving party must confer with opposing counsel in a good faith effort to resolve the issues raised by the motion before filing, and must include a certificate in the motion indicating whether opposing counsel objects. The Court reminds Defendants Jackson and Timothy Hunte DBA KATT Distribution that they must follow all rules lawyers are required to follow, even though they are proceeding pro se.
