After that 60 day period, however, without further order, this dismissal shall be deemed with prejudice. Although the Court normally does not retain jurisdiction to ensure performance of a settlement agreement, given the circumstances presented here, the Court will retain jurisdiction until April 8, 2022, for the purpose of entering a judgment in the event of default.
