**ENDORSED ORDER:** The receiver initiated this action on April 14, 2020. (Doc. # [1]). On October 30, 2020, the Court entered an order scheduling the mediation for March 30, 2021, in front of Peter Grilli. (Doc. # [552]). On December 2, 2020, Defendant David Wilkerson filed his pro se answer to the complaint. (Doc. # [674]). Although Peter Grilli cancelled the mediation on February 12, 2021 (Doc. # [712]), the Court subsequently appointed Gregory Holder and confirmed that the mediation was still set for March 30, 2021. (Doc. # 713). On March 31, 2021, the mediator reported that Defendant Wilkerson did not attend the mediation. (Doc. ## [732], [733]). Accordingly, Defendant Wilkerson is ordered to show cause by April 19, 2021, why his answer should not be stricken from the record. If Defendant Wilkerson does not respond by that date, the Court will strike his answer and the receiver should forthwith move for entry of default.
