PLAINTIFF'S MOTION FOR ENTRY OF CLERK'S DEFAULT AGAINST DEFENDANT BETSY DOOLIN

Civ. P. 55(a) and this Court's April 1, 2021 Order to Show Cause Directed to Defendant Betsy Doolin (Doc. 736), moves the Clerk of Court to enter a default against Defendant, BETSY DOOLIN ("*Doolin*"), and states:

1. On April 14, 2020, Plaintiff filed his Complaint against Doolin (Doc.

- 2. On July 23, 2020, Doolin filed her *pro se* Answer to the Complaint (Doc. 291).
- 3. On October 30, 2020, the Court entered an order scheduling the mediation for March 30, 2021 in front of Peter Grilli (Doc. 552).
- 4. Although Peter Grilli cancelled the mediation on February 12, 2021 (Doc. 712), the Court subsequently appointed Gregory Holder and confirmed the mediation was still set for March 30, 2021 (Doc. 713).
- 5. On March 31, 2021, the mediator reported that Doolin did not attend the mediation (Docs. 732, 733).
- 6. On April 1, 2021, Doolin was ordered to show cause by April 19, 2021, why her Answer should not be stricken from the record. The order stated that if Doolin does not respond by that date, the Court will strike her Answer and the receiver should forthwith move for entry of default (Doc. 736).
- 7. As of the date of this filing, Doolin has not filed a response to the Order to Show Cause.

WHEREFORE, Plaintiff moves the Clerk of Court for entry of a Clerk's Default against Doolin.
