ENDORSED ORDER: On the basis of the Receiver's notice of resolution (Doc. # [799]), this cause is hereby dismissed as to Defendants Timothy Hunte, Timothy Hunte DBA Katt Distributors, and James Jackson, without prejudice and subject to the right of the parties, within 60 days of the date hereof, to submit a stipulated form of final order or judgment, or request an extension of time, should they so choose or for any party to move to reopen the action, upon good cause being shown. After that 60 day period, however, without further order, this dismissal shall be deemed with prejudice. Although the Court normally does not retain jurisdiction to ensure performance of a settlement agreement, given the circumstances presented here, the Court will retain jurisdiction until October 8, 2021, for the purpose of entering a judgment in the event of default.
