**ENDORSED ORDER:** On May 12, 2021, the receiver moved for summary judgment against Defendants Offer Attia, Timothy Hunte DBA KATT Distribution, Joseph Martini, Jr., and David Wilkerson. David Wilkerson's notice of settlement was filed on May 18, 2021 (Doc. # [798]), Timothy Hunte DBA KATT Distribution's notice was filed on May 18, 2021 (Doc. # [799]), Offer Attia's notice was filed on June 1, 2021 (Doc. # [806]), and Joseph Martini, Jr.'s notice was filed on June 1, 2021 (Doc. # [807]).
