**GARNISHEE’S ANSWER TO WRIT OF
GARNISHMENT REGARDING RICHARD HUBBARD**

Garnishee, Valley Bank (“Garnishee”), answers the Writ of Garnishment (“Writ”) (D.E. 857) dated June 17, 2021, regarding Defendant, Richard Hubbard

(“Defendant”), served by Plaintiff, Burton W. Wiand, as Receiver for Oasis International Group, Ltd.; Oasis Management, LLC; and Satellite Holdings Company (“Plaintiff”), as follows:

1. Garnishee's records reflect that Garnishee is indebted to Defendant by virtue of the following account:

2. Pursuant to its account agreement, Garnishee is entitled to deduct a fee of \$100 for processing the Writ. In addition, Garnishee retains \$0.01 in order to keep the account open after garnishment. Pending the Court’s determination of whether any of the amount above is subject to garnishment, the amount available after deduction of the processing fee and amount to keep the account open is **\$761.93**.

3. Garnishee does not know of any other person indebted to Defendant who may have any effects, goods, money, or chattels of Defendant, nor does Garnishee have in its possession or control any tangible or intangible property of Defendant.

4. Garnishee hereby demands payment of its attorney's fees and costs, pursuant to Florida Statutes § 77.28.

Wherefore, Garnishee respectfully requests that the Court enter a final judgment in garnishment determining the proper disposition of funds in the above account; enter an order awarding Garnishee its attorney's fees and costs, including the fee for processing the Writ; and afford Garnishee such other relief as is just and proper.
