**SECOND NOTICE REGARDING
SUBSTITUTED SERVICE ON CERTAIN RESPONDENTS
FOR JULY 15, 2026, ORDER TO SHOW CAUSE HEARING**

On July 1 and 6, 2026, the Court granted two motions filed by Burton W. Wiand, the Court-appointed receiver over the assets of the above-captioned defendants and relief defendants (the “**Receiver**”), to approve substituted service of the Receiver’s motion for an order to show cause (Doc. 904) (the “**Show Cause Motion**”) and the Court’s order granting the Show Cause Motion (Doc. 927) (the “**Show Cause Order**,” and, collectively, the “**Service Documents**”) via (1) the Florida Secretary of State on Jason McKee, Greg Melick, and Brent Winters (collectively, “**Respondents**”); (2) email and U.S. mail under Illinois law on McKee; and (3) email under Indiana law on Winters. *See Docs. 936, 939.*

On July 1, 2026, the Receiver filed the Service Documents and the Court's order (Doc. 936) with the Florida Secretary of State. Importantly, the filing website states that the pertinent staff are still processing applications submitted between June 19 and June 25, 2026. A copy of the relevant webpage is attached as **Exhibit A**. As such, it appears unlikely that the staff will process the Receiver's application before the July 15, 2026, hearing – not to mention the additional steps the Receiver must take after receiving approval from the Secretary of State. This primarily affects Respondent Melick, as he cannot be served by mail or email under New Hampshire law. This is particularly unfortunate because Melick appears to be the ringleader of the Helper's Group's efforts. The Receiver, however, has retained a process server who is attempting to effectuate personal service as a last resort. The Receiver will update the Court if those efforts prove successful, but the Receiver is also contemplating moving the Court to continue the July 15, 2026, hearing to allow Melick to be served so that full relief can be afforded against all Respondents as opposed to a piecemeal or incomplete adjudication.

On July 1, 2026, undersigned counsel sent the Service Documents to Brent Winters by mail and email, thereby effectuating service under the Court's order (Doc. 936) and Indiana law. A copy of that correspondence is attached as **Exhibit B**.

On July 6, 2026, undersigned counsel sent the Service Documents to Jason McKee by U.S. mail and email, thereby effectuating service under the Court's order (Doc. 939) and Illinois law. A copy of that correspondence is attached as **Exhibit C**.

In summary, Respondents Winters and McKee have been served. A process server is still trying to personally serve Respondent Melick. Service through the Florida Secretary of State is pending due to delays within that office. The Receiver will keep the Court informed of further developments.
