WRIT OF HABEAS CORPUS AD TESTIFICANDUM

TO: Any United States Marshal, the Pinellas County Sheriff, and the Warden of FCI Coleman

Low

It appearing that Defendant Michael DaCorta is confined at Pinellas County Jail, located
at 14400 49th Street N, Clearwater, FL 33762, that this case is set for a show-cause hearing on the

Receiver's motion to hold certain individuals, including Michael DaCorta, in civil contempt on August 7, 2026, at 10:00 a.m., and that it is necessary for Michael DaCorta to be before the Court for said proceeding:

NOW, THEREFORE, this is to command you, any United States Marshal, that — as the show-cause hearing originally scheduled for July 15, 2026, has been continued until August 7, 2026 — you return Michael DaCorta with all convenient speed, under safe and secure conduct, to the custody of the Warden of FCI Coleman Low.

And, this is to command you, Pinellas County Sheriff, to deliver into custody of any United States Marshal, upon production to you of a certified copy of this writ, the body of Michael DaCorta for the purpose aforesaid.

ADDITIONALLY, this is to command you, any United States Marshal, that you have the body of Michael DaCorta, who will be detained in custody in FCI Coleman Low, located at 846 NE 54th Terrace, Sumterville, FL 33521, under safe and secure conduct, before this Court on August 7, 2026, in Tampa, Florida, by or before 10:00 a.m., for the purpose of attending and possibly testifying in the above proceeding.

And, this is to command you, Warden of FCI Coleman Low, to deliver into custody of any United States Marshal, upon production to you of a certified copy of this writ, the body of Michael DaCorta for safe and secure conduct to this Court for the purpose aforesaid.

FURTHERMORE, this is to command you, any United States Marshal, that — upon completion of all further proceedings in this case — you return Michael DaCorta with all convenient speed, under safe and secure conduct, to the custody of the Warden of FCI Coleman Low.
